Reporting to the Director, Community Addiction & Mental Health Services, the Assertive Community Treatment Team (ACTT) Supervisor is an experienced clinician who provides clinical and administrative leadership to ACTT with responsibility to oversee a multidisciplinary team providing services to individuals living with, and recovering from, a severe and persistent mental illness within the Stormont, Dundas and Glengarry counties and including residents of the Akwesasne community.

The Supervisor is responsible for the day-to-day operations of the ACT Team, and strives for positive outcomes for consumers that include reduced hospital utilization, improved psychosocial functioning, and achievement of person-centered goals. The Supervisor is an expert in ACT eligibility and program requirements and has a solid understanding of multiple evidenced based practices including; Integrated Concurrent Disorders Treatment, Recovery Oriented Practice, Trauma Informed Care, Family Support/Education and the ACTT Standards.

The ACTT Supervisor upholds the mission, vision and ICARE values of the Cornwall Community Hospital, in order to create a safe environment for patients/clients, families, staff, physicians and volunteers, recognizing “Patient Safety” and our hospital’s “Senior Friendly Strategies” as a top priority in creating a culture of safety and “The Workplace of Choice”.

- College Diploma in related health care or counselling discipline
- Minimum five years’ direct clinical experience working with individuals with serious mental illness living in the community
- Demonstrated knowledge of the ACTT model of service delivery
- Knowledge of the Assertive Community Treatment Team Standards for Ontario (MOHLTC)
- Familiarity with key legislation such as the Ontario Mental Health Act
- Knowledge of the issues affecting people who the ACT Team works for, including their caregiver and support systems (e.g. poverty, unemployment, stigma, isolation)
- Knowledge of community services and the ability to foster effective service linkages and partnerships
- Ability to lead and coordinate a multi-disciplinary team
- Ability to prioritize needs and organize work efficiently
- Ability to work with agencies, hospitals and the broader community
- Excellent oral and written communication skills
- Proficient in Microsoft Office
- Ability to efficiently manage budget and human resources
- An understanding of continuous improvement principles
- Valid driver’s license and reliable means of transportation on a regular basis and an acceptable driving record
- Demonstrated commitment to patient safety
- Functional proficiency in oral and written English
